OPINION: Gov. should embrace GOP bills to fix 'catch-and-release' and help secure southern border

The Albuquerque Journal's July 13 Sunday Journal editorial calling on state legislators to "put the politics aside and embrace the governor's public safety agenda" sadly was filled with inaccuracies on what Republican legislators have been saying about the proposed July 18 special session.

Unfortunately, this narrative was expanded upon Monday, at a press conference that was held by House and Senate Democratic leadership. To set the record straight, House Republicans have never urged the governor to cancel the special session. Rather, the House Republican leadership sent a letter to the governor on June 10 stating if she was serious about addressing New Mexico's crime issues, she should support bills that would fix our state's "catch—and—release" problem, increase criminal penalties for the trafficking of fentanyl and adopt proposals to help secure our state's southern border.

To this day, the governor has not responded to our letter, but her staff has told media outlets that she does not support increasing penalties for fentanyl trafficking, nor does the governor possess any desire to address the border situation during the special session. Instead, the governor continues to push proposals which, contrary to her claims, will barely make a dent in protecting New Mexicans or make us feel safe in our homes.

Unfortunately, the Journal Editorial Board ignored the glaring question as to why past crime legislation has failed. The state Legislature is dominated by progressive Democrats who are opposed to holding criminals accountable for their actions. This was apparent in the Democratic leaders' press conference, when they couldn't even support the weakest of crime legislation.

Progressives believe that the criminal justice system, bad cops and "systemic racism" are responsible for the actions of these poor criminals.

That being said, House Republicans are not against the governor calling a special session to address public safety. Republicans are against having a special session that deceives the public, and the media, for that matter, into believing that we are addressing crime when we, in fact, are not.

Until there is a fundamental change in New Mexico's leadership, progressive politicians will continue to feign their intent to address our crime problems. However, just as we see with the governor's "public safety" agenda, these so-called solutions have no real impact in making our communities safer, and any of their stated concern about reducing crime will evaporate once the election season is over. I don't care whether the Journal prints this opinion or not. I just need you to know how frustrating it is when you get our position completely wrong, even when you are provided with all of the information necessary to get it right.
