In 2005, Doña Ana County District Attorney Susana Martinez had a nearly beheaded teenage corpse on a ditch bank. In 2006, Bernalillo County Sheriff Darren White had a deputy dead in the East Mountains.

Federal law enforcement agencies led by the FBI were there to help. But Martinez and White said they had to kick and scream to get the attention of the U.S. Attorney's Office, run by fellow Republican David Iglesia.

Martinez threatened to go to the president of the United States to get help in her case. It worked, and federal prosecutors took over the drug-related kidnapping and homicide.

White's investigators wanted help from fed-eral prosecutors in getting wiretaps in their investigation into the slaying of Deputy James

With states moving up their contests, will second-tier candidates like Bill Richardson lose out?

ne political pro is calling it the "Powerball Primary:" The question is whether andidates like Gov. Bill Richardson will wind up holding the winning — or losing — tickets.

An unprecedented number of states are clamoring to schedule their 2008 presidential nominating

contests on Feb. 5.

At last count, nearly two dezen states — including biggies such as California, New York and Tex California of the calendar or wore considering it.

And some observers believe that cramming so many nominating contests into a singlo, historic Super Tuesday could leave lesses known, lesses-funded candidates like Richardson in a political crunch.

"The more states that pile on to certain dates — particularly with the Feb. S date — the more it will take to

get out (a candidate's) message and be a viable competitor," said Kay Stimson, a spokeswoman for the nonpartisan National Association of Secretaries of State, which is trying to reverse the trend of the so-called "front-loaded" primary schedule. "... It's going to require an enormous sum of money—an unprecedented level—in order to compete."

The Richardson campaign, meanwhile, said it doesn't see the Powerball Primary — a nickname
